EBCP GOVERNANCE

- 1) Cancer Plan Implementation Group consisting of all relevant Commission services. To ensure alignment between the Plan and the Mission, the existing Cancer Mission Owners Group3 will be fully integrated. The Implementation Group is chaired jointly by DGs SANTE and RTD.
- 2) Member State cancer sub-group of the Steering Group on Health Promotion and Disease Prevention (SGPP). The sub-group will follow jointly the implementation of the Cancer Plan
- 3) Stakeholder contact group under SANTE's Health Policy Platform (HPP). It is planned that this group will consist of a general assembly, which will include patient groups and all interested stakeholders and more specific sub-networks with limited participation, which could be organised along the pillars of the Cancer Plan.
